## AUTHORIZATION AND RELEASE: NON-SCHOOL TRANSPORTATION FROM DISTRICT SPONSORED EVENTS

Illini West High School District No. 307 permits parent or guardians to authorize their child to be transported from certain school events and/or extra-curricular activities by persons the parents have approved in writing with respect to that event. The administration, in case of particular events, may require the students ride only on school transportation in their discretion. In no case will school transportation be altered or delayed by alternate transportation, nor will school transportation drop or release a student enroute for meeting alternate transportation. Administrators and coaches/sponsors may decline to allow the alternate transportation for other reasons within their complete discretion, such as unusual conditions or weather. Parents or guardians may name a particular event or give permission for the entire activity, etc. basketball season. A new form must be filled out for all activities.

I understand and agree that Illini west High School District No. 307 and its employees and agents shall have no responsibility for transportation hereby authorized by me, and that neither the School District nor District employees or agents shall exercise any responsibility or control over, or supervise any non-school transportation. I have satisfied myself as to the safety, appropriateness, and suitability of the alternate transportation, and the competence of the driver. I understand that the School District and its employees may not honor this request and that this decision is in their complete discretion, which may include a determination that either the means of transportation or the driver is not responsibly safe or appropriate.

In consideration of my child being permitted to be transported by other than school-provided transportation to or from the above-listed event, I release, and agree to indemnify and hold Illini West High School District No. 307, its Board of Education, officers, employees, administrators and agents harmless from any and all claims, suits, damages or costs arising out of, or in any way related to this alternate transportation of my child.

This form will not be accepted at the event in question allowing the child to be taken home by alternative means. The person authorized to take the child home must sign the child out through the sponsor and may be request to present a driver's license to the sponsor.
