<u>ORDINANCE</u>

NO. 1819-0620

WHEREAS, the State of Illinois has enacted "An Act regulating wages of laborers, mechanics and other workers employed in any public works by the State, county, city or any public body or any political subdivision or by any one under contract for public works," approved June 26, 1941, codified as amended, 820 ILCS 130/1 et seq. (1993), formerly Ill. Rev. Stat., Ch. 48, par. 39s-.01 et seq. and

WHEREAS, the aforesaid Act requires that the board of the Illini West HSD #307 of Hancock County investigate and ascertain the prevailing rate of wages as defined in said Act for laborers, mechanics and other workers in the locality of Hancock County employed in performing construction of public works, for said district.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF ILLINI WEST HSD #307:

SECTION 1: To the extent and as required by "An Act regulating wages of laborers, mechanics and other workers employed in any public works by State, county, city or any public body or any political subdivision or by any one under contract for public works," approved June 26, 1941, as amended, the general prevailing rate of wages in this locality for laborers, mechanics and other workers engage in construction of public works coming under the jurisdiction of Illini West HSD #307 is hereby ascertained to be the same as prevailing rate of wages for construction work in Hancock County area determined by the Department of Labor of the State of Illinois as of June, 2018, a copy of that determination being attached hereto and incorporated herein by reference. As required by said Act, and all revisions of the prevailing rate of wages by the Department of Labor of the State of Illinois shall supersede the Department's June determination and apply to any and all public works construction undertaken by said District. The definition of any terms appearing in this Ordinance which are also used in aforesaid Act shall be the same as in said Act.

SECTION 2: Nothing herein contained shall be construed to apply said general prevailing rate of wages as herein ascertained to any work or employment except public works construction of said District to the extent required by the aforesaid Act.

SECTION 3: The District shall publicly post or keep available for inspection by any interested party in the main office of the District this determination or any revisions of such prevailing rate of wage. A copy of this determination or the current revised determination of prevailing rate of wages then in effect shall be attached to all contract specifications.

SECTION 4: The secretary of the District shall mail a copy of this determination to any employer, and to any association of employers and to any person or association of employees who have filed their names and addresses, requesting copies of any determination stating the particular rates and the particular class of workers will be affected by such rates.

SECTION 5: The secretary of the District shall promptly file a certified copy of this Ordinance with the <u>Department of Labor</u> of the State of Illinois and the Secretary of State of the State of Illinois.

SECTION 6: The secretary of the District shall cause to be published in a newspaper of general that the

circulation within the area a copy of this Ordin determination is effective and that this is the d	ance, and such p	publication shall constitute notice this public body.
